### Dates & Show Times

### Set-Up Time

Friday, August 11 from 9:00 am – 1:30 pm. No vehicles will be allowed in the vendor area after 1:30 pm. If you arrive after 1:30 pm you must proceed directly to vendor parking and get your items to your booth from the parking area. Sat, Aug 12 from 8:00 – 9:30 am and Sun, Aug 13 from 8:00 – 9:30 am.

### Booth Space

15' Across x 10' Deep (some can be 20' across). When applying for a booth please consider the size of your tent. If your tent has rope extensions, the extensions must be within the booth space. There are approximately 75 Flea Market sites available. Most of the sites are in a shaded, wooded area with dirt ground covering. Some of the sites are in the open and do not have shade.

### Booth Fee

**\$70 per booth if received by Mar 1, 2017 /\$100 per booth after Mar 1, 2017**

### Storage Availability

**A limited number of booths are large enough so vendors can leave a Stationary Storage Trailer behind their canopy (this is not a vehicle you move at the end of each day – once parked there it must remain until the end of the festival on Sunday.)** These spaces are available on a first come, first served basis. Advance registration for this opportunity is required. The cost for this opportunity is \$15. You will be provided with a separate parking pass that must be visible on the storage vehicle all weekend.

### Items For Sale

**Flea Market vendors are not allowed to sell bottled water from their booth. This is reserved for our Food Vendors.** You must list all the items you will be selling on your application (use the back of the application if needed). Writing "General Merchandise" will not be accepted.

### Parking

Each booth will be provided with one parking pass. When you arrive at registration on Fri, Aug 11 – it must be displayed on your rear view mirror and remain there throughout the weekend. All vehicles must park in the designated vendor parking area (unless it is a stationary storage vehicle and you have paid to leave it behind your booth – **absolutely no vehicles will be allowed to park next to canopies in booth spaces**). Golf cart shuttles will be available to get you to your booth from parking during vendor set up and then back to your vehicle at the end of the day. During the day, instead of shuttling vendors, the golf carts will be concentrating on transporting senior citizen and handicap customers to and from their vehicles.

### Overnight Camping

A limited number of spaces are available for self-contained RV's (not cars, vans, trucks, tents, etc.) west of the Sledding Hill where all vendor vehicles park. There will be no water or electrical hookups and vendors are restricted from building fires and dumping water and/or waste. Advance registration for this opportunity is required. The cost for this opportunity is \$15.

### Vendors Responsibility

Vendors are responsible for supplying as well as setting up and taking down their own displays, dividers, tents, tables and chairs. **Vendors are not allowed to sell wares from boxes on the ground.** Vendors must stay within the confines of their booth to sell their wares – you are unable to walk around the park selling your wares. Vendors are expected to keep their booth area clean at all times and dispose of trash & cardboard in the appropriate receptacles provided. Vendors are expected to remain open for business until closing on all three days. Early

teardown and departure will not be tolerated and you will not be asked to participate in future Festivals.

### **Animals**

No dogs or other animals are allowed on the festival grounds during the weekend.

### **Electricity**

**There is no electricity available** in the Flea Market area of the park. If you require electricity, you may bring a Whisper Quiet generator. In consideration of your neighboring vendors & our shoppers, no other generators will be allowed – no exceptions. Gas cans must not be visible to shoppers.

### **Food & Activities**

There are food booths and family activities all weekend long within the park. At registration you will be provided with a festival guide that will list all the events, what food vendors have & where everything is located.

### **Publicity**

Advertisement of the St. Johns Mint Festival begins in January 2017 and continues through the start of the festival. We utilize paid newspaper advertisement (over 10 newspapers) (over 110,000 inserts), radio and TV spots. We are listed in the Michigan Festivals & Events Guide and are listed on over 10 festival, craft show and flea market websites. We distribute over 9,000 festival brochures throughout the state, hang 250 poster and print over 33,000 festival programs that are included in newspapers the week before the festival. If you would like flyers to distribute at other shows, please call 989-224-7248 and we will mail them to you.

### **Sending in Application**

Complete the attached application form if you wish to participate as a Flea Market vendor for the 2017 St. Johns Mint Festival. Enclose a check for the full amount of the requested booth space(s) made payable to the **“St. Johns Mint Festival”** or charge the fee to your credit card.

List all the items you will be selling from your booth. This will help us in assigning you a booth space so we do not have too much of any one type of product next to each other. Also include a self-addressed and stamped envelope. If we are unsure what your product is from your description, we may request photographs.

Liability Insurance: All vendors are required to have liability insurance with a limit of at least \$25,000.

### **Due Date**

New vendor applications received prior to March 1, 2017 will be processed, but will not be assigned a booth space until after March 1, 2017.

If the committee does not accept your application, your check will be returned to you. You will know your application has been accepted when your check is cashed. An official confirmation will be mailed to you.

The St. Johns Mint Festival Committee reserves the right to reject any application both at the time of receipt and at the show, based on the information provided, the products actually brought to be sold or other circumstances.

### **Cancellation**

If you cancel your participation in the show before an official confirmation is mailed, you will receive a refund, minus a \$25 processing fee. **If you cancel your participation in the show after an official confirmation is mailed, no refund will be given.**
